(Lafayette) School reform from within and without is the theme of the League of Women Voters® of Louisiana state Council meeting "Louisiana Public Education and Government: Standing at the Tipping Point" March 31, in Shreveport. The panel is scheduled for 12:00-1:00 p.m. at the Broadmoor Branch, Shreveport Memorial Library at 1212 Captain Shreve Drive.

Keynote speakers are Scott Hughes, Executive Director, Alliance for Education and Melissa Flournoy, Executive Director, Louisiana Progress. The keynote speakers will present different perspectives to engage the public on the issue of the future of public education in Louisiana.

Over the last two years the local Leagues of St. Tammany, New Orleans and Lafayette have participated in two studies conducted by the League of Women Voters of the United States: The Role of the Federal Government in Public Education, and Privatization of Government Assets & Services. The Louisiana League has examined best practices in early childhood education and current initiatives in Louisiana. These studies have provided a wide national background for the issues facing public education in Louisiana historically, economically and politically.

The League of Women Voters of Louisiana supports measures to strengthen public education at all levels. It supports adequate funding of public schools and emphasizes a major proportion of cost born by the state. It also favors a more balanced formula for state monies supporting education of mainly agricultural parishes with those of larger cities and more businesses. The League also supports equalization of assessments and extension of state support to include capital outlay such as school construction. It does not support the use of public funds for non-public schools.

The panel presentation is free and open to the public. Lunch is available for \$15. Please call Carol DeVille at (318)288-8199 to order a box lunch.
